AN ORDINANCE ESTABLISHING THE DOVERA COMMUNITY DEVELOPMENT DISTRICT PURSUANT TO CHAPTER 190. FLORIDA STATUTES (1991); SPECIFYING GENERAL AND SPECIAL POWERS OF THE DISTRICT IN AN ADOPTED CHARTER; DESCRIBING THE BOUNDARIES OF THE DISTRICT IN AN ADOPTED CHARTER; NAMING THE MEMBERS OF THE BOARD OF SUPERVISORS IN AN ADOPTED CHARTER; PROVIDING FOR THE ADMINISTRA-TION, OPERATION AND FINANCING OF THE DISTRICT IN AN ADOPTED CHARTER; PROVIDING FOR AN AP-PROVED CHARTER FOR THE DISTRICT: PROVIDING FOR THE ENTERING OF AN INTERLOCAL AGREEMENT BE-TWEEN THE COUNTY AND THE DISTRICT; PROVIDING FOR SEVERABILITY AND INCORPORATING EXHIBITS; PROVIDING FOR CODIFICATION; PROVIDING EFFECTIVE DATE

WHEREAS, The Viera Company, which is the property owner of all of the real property described in Exhibit "A" hereto which is incorporated herein as if fully set forth herein verbatim, has petitioned the Board of County Commissioners of Seminole County (the "County") to adopt an ordinance establishing the Dovera Community Development District (the "District") pursuant to the provisions of Chapter 190, Florida Statutes (1991); and

WHEREAS, The Viera Company is a Florida corporation authorized to conduct business in the State of Florida whose corporate address is Box 257; Highway 426; Oviedo, Florida 32765 and whose President is Joseph Duda; and

WHEREAS, the creation of the District will constitute a timely, efficient, effective, responsive and economic way to deliver community development services in the area described in the CERTIFIED COPY

WHEREAS, a duly noticed evidentiary public hearing regarding the Petition was held on March 12, 1992; and

WHEREAS, the Board of County Commissioners held, on April 14, 1992, a duly advertised public hearing relating to the adoption of this Ordinance; and

WHEREAS, all statements contained in the Petition have been found to be true and correct; and

WHEREAS, the creation of the District is not inconsistent with any applicable element or portion of the State Comprehensive Plan as set forth in Chapter 187, Florida Statutes (1991), or the 1991 Seminole County Comprehensive Plan; and

whereas, the area of land within the District is of sufficient size, is sufficiently compact and is sufficiently contiguous to be developable as one (1) functional interrelated community; and

WHEREAS, the creation of the District is the best alternative available for delivering the community development services and facilities to the area that will be served by the District as described in the Petition; and

WHEREAS, the proposed services and facilities to be provided by the District will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and WHEREAS, the area that will be served by the District is amenable to separate special-district government.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA

SECTION 1. CREATION OF DOVERA COMMUNITY DEVELOPMENT DISTRICT/INITIAL DISTRICT BOARD.

- (a) There is hereby created a community development district within the property described in Exhibit "A" hereto and located in Seminole County, Florida which District shall be known as the "Dovera Community Development District" and which shall operate in accordance with the Charter attached as Exhibit "B" hereto which is incorporated herein as if fully set forth herein verbatim.
- (b) The exercise by the District of its powers shall comply with all applicable governmental laws, rules, regulations and ordinances governing planning and permitting of the development to be serviced by the District including, but not limited to, plans submittal, review and approval. Neither the establishment nor the operation of the District is a development order under Chapter 380, Florida Statutes (1991).
- c) The District shall not have and may not exercise any zoning or development permitting power. All Seminole County planning, building, environmental and land development laws, rules, regulations and ordinances apply to all development of land within the District including plans submittal, review and approval. The District shall take no action which is inconsistent with the 1991 Seminole County Comprehensive Plan, as amended from time to time.

(d) The initial District Board shall consist of the following five (5) members whose address as set forth in the Petition:

- (e) The County hereby consents to the District engaging in the following activities which require, pursuant to Section 190.012(2), Florida Statutes (1991), the County's consent:
- (1) Parks and facilities for indoor and outdoor recreational, cultural and educational uses;
 - (2) Security as authorized by law; and
- (3) Control and elimination of mosquitoes and other arthropods of public health importance.
- (f) The District shall not have the power of eminent domain beyond the boundaries of the District.
- SECTION 2. INTERRELATIONSHIP WITH DLI PROPERTIES DEVELOPMENT OF REGIONAL IMPACT DEVELOPMENT ORDER AND RELATED DEVELOPMENT ORDERS AND PERMITS; PUBLIC FACILITIES.
- (a) This Ordinance shall not, in any way, reduce the developer's obligations under or modify the terms and conditions of the DLI Properties Development of Regional Impact Development Order and related development orders or permits including, but not limited to, the Planned Unit Development (PUD) Commitment Agreement and the DLI Properties PUD Final Master Plan and Commitment Agreement; provided, however, that it is hereby determined that the

roads reflected in the above-referenced development orders and permits do not equal or exceed the County's specifications.

- (b) All roads constructed by the District shall meet or exceed the County's specifications.
- (c) The District, upon constructing major water and sewer lines (to parcel boundaries), shall convey said lines to the County pursuant to instruments of conveyance acceptable to the County.
- (d) This Ordinance shall not be deemed or construed to vest any development permitting or regulatory authority in the District or to divest the County of any development permitting or regulatory authority. The District shall be subject to and pay any and all fees for County reviews, processes and permits in those circumstances when the District seeks County approvals.
- (e) Insofar as the terms of the DLI Properties Development of Regional Impact Development Order require the Developer to provide or maintain certain infrastructure, facilities or services, the District may, with the consent of the Developer, assume and satisfy all or part of the Developer's obligation to provide such improvements or services in accordance with the terms of the said Development Order.

SECTION 3. SEVERABILITY/EXHIBITS.

(a) If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, it is the intent of the Board of County Commissioners that the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision or

application and, to this end, the provisions of this Ordinance are declared severable; provided, however, that nothing herein and no occurrence resulting from the provisions of this Ordinance being severed shall be deemed in any way to authorize or provide for any of the obligations, indebtedness, duties or responsibilities of the District to be assumed by the County or its taxpayers in any way unless specifically consented to, in writing, by the County; provided, further, however, that nothing herein and no occurrence resulting from the provisions of this Ordinance being severed shall result in the developer or the successor to the developer as to the development orders referred to in Section 2 being relieved of any obligation or conditions therein.

(b) The Exhibits hereto are incorporated into this Ordinance as operative parts thereof.

SECTION 4. DEFINITIONS. Definitions utilized for this Ordinance and the Exhibits shall be those as set forth in Chapter 190, Florida Statutes (1991).

SECTION 5. CODIFICATION. It is the intention of the Board of County Commissioners that the provisions of this Ordinance shall become and be made a part of the Seminole County Code and the word "ordinance" may be changed to "section," "article," or other appropriate word or phrase and the sections of this Ordinance may be renumbered or relettered to accomplish such intention; providing, however, that Sections 5 and 6 shall not be codified.

SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect upon receipt of official acknowledgment by the Clerk of the Board

of County Commissioners from the Department of State that this Ordinance has been filed with the Department of State; provided, however, that, if an Interlocal Agreement is substantially the form attached as Exhibit "C" hereto is not executed by the District on or before June 1, 1992, this Ordinance shall sunset and be of no further force nor effect.
